WHEREAS the Sree Chaitanya Mahavidyalaya 2<sup>nd</sup> cycle NAAC accredited college, with a view to improve Advancement of Learning and Need based Higher Education, desirous to exchange various fields of the institutions proposed Nabadwip Vidyasagar College 2<sup>nd</sup> Cycle NAAC accredited college to join hands with them. Nabadwip Vidyasagar College (Second Party) as the Second Party accepted the proposal of the First Party.

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSETH and it is agreed by and between both the Colleges hereto as follows:-



1. SCM & NVC have the necessary permission of the concerned Governing Bodies regarding the MOU.
2. That for the purpose mentioned *ut supra* both the colleges have agreed to exchange in the fields like Academic Exchange (including the joint classes held for the students of both the colleges, by the faculties of different departments) in a week / fortnight, the *modus operandi* of which will be settled jointly by the concerned departments of both the colleges.
3. Cultural exchange like commemoration of birth anniversaries of renowned personalities, observance of different International / National Days, celebration of local festivals, inter-college cultural competitions etc. may be organized jointly.
4. NSS activities: The colleges can share a few programmes of NSS activities as per the convenience and feasibility from both the colleges' end.
5. Research and Publication: Collaborative endeavours can be undertaken to publish research articles either in the proceedings of National and International seminars / webinars etc., and / or in the form of edited volumes. A well-concerted contribution of the academic journals of both the colleges, publishing of Students' Magazines / webzines, departmental e-journals etc.
6. Library facilities: Resources of both the colleges can be shared, *modus operandi* of which will be settled jointly by the Library departments of the colleges.
7. It is agreed by both the colleges that expenses to be incurred in connection with different programmes will be borne by the respective college of the participants/candidates.
8. Both the colleges have agreed that if additional assistance is required in that event Principal of both colleges will settle mutually after discussions.
9. That in respect of the abovementioned programmes and/or activities only Principals of both the colleges will take all responsibilities regarding selection of candidate(s)/participant(s) and other matters of the said purpose.
10. If any disputes arise in respect of this MOU in that case Principal of both the colleges will discuss and settle the matter amicably.
11. Both the colleges have entered into this Memorandum of Understanding for the period of two years in first phase.

The Memorandum of Understanding (MoU) is effective as of 01/01/2022 (Effective date) to establish an affiliation by and between

Asannagar Madan Mohan Tarkalankar College, Asannagar, a West Bengal Government Aided undergraduate degree College with its office at Asannagar, Block – Krishnagar-I, Dist – Nadia, West Bengal (India), Pin – 741161, established in 2007 affiliated to University of Kalyani, hereinafter referred to as Asannagar Madan Mohan Tarkalankar College and represented by its Principal, referred to as FIRST PARTY,

### AND

Nabadwip Vidyasagar College, a West Bengal Government Aided undergraduate Degree College with its office at Pacca Tole Road, P.O. – Nabadwip, District – Nadia, West Bengal (India), Pin – 741302, established in 1942, hereinafter referred to and represented by its Principal, referred to as SECOND PARTY, for the purpose of exchange of students, staff and faculty.

The aforesaid institutions are hereinafter referred to individually/ collectively as college/ colleges

### PREAMBLE

Whereas, Asannagar Madan Mohan Tarkalankar College and Nabadwip Vidyasagar College have many areas of common interest in Arts and Science, considerable advantage may be gained from their pursuit of academic excellence on a collaborative basis in the fields of academics, pedagogy and research.

Now therefore, Asannagar Madan Mohan Tarkalankar College and Nabadwip Vidyasagar College have decided to enter into this Memorandum of Understanding (hereinafter referred to as MoU), which defines the framework for the cooperation of the two institutions in the following sections.

### ARTICLE 1: OBJECT

Both colleges agree to develop the following collaborative activities in the academic areas of mutual interest, on the basis of equality and reciprocity.

The two institutions shall seek to promote:

#### A. Faculty/ Staff exchanges

- i) Each institution will promote the exchange of faculty for the common UG Honours & Programme Courses.
- ii) Faculty exchange for the mutual benefit of both the institutions.
- iii) Collaboration in teaching, research and development, and consultancy studies in the field of mutual interest.
- iv) Exchange of academic materials and publications
- v) Conducting lectures
- vi) Undertaking joint research wherever feasible
- vii) Participating in seminars, workshops, symposia, other kinds of academic discussions,
- viii) Conducting study tours and joint consultancy work wherever feasible
- ix) Each Teacher will be responsible for her/his own transportation and daily allowances to and from the host institution.

- x) Exchange of non-teaching staff on proper need-based situations for assistance/skill or knowledge development in areas pertaining to their areas of work, with allowances as agreed upon by the Coordination Committee.

A specific plan will be worked out for each activity and detailed arrangements for such collaborative work will be agreed upon.

## **B. Student Exchange**

- a) Students in the exchange programme will be selected by mutual agreement between the home and the host college.
- b) Students in an exchange programme may be evaluated by the host institution if such an evaluative framework for the academic interest of students be worked out; this will in no way impede or influence her/ his evaluation in home college or university assessment/ evaluation.

## **C. Other areas**

- a) To exchange information on research and educational programmes
- b) To exchange information on teaching, learning material and other literature relevant to their educational and research programmes.
- c) To jointly organize seminars, faculty development programmes, workshops on topics of mutual interest and to invite each other's faculty to participate therein.
- d) To explore the provision of cultural and intellectual enrichment opportunities for staff, faculty and students of both institutes.
- e) To use library reading room facilities for a specified period.
- f) To use laboratory facilities in specific cases (with prior approval of Principal) for a limited period.

Asarnagar Madan Mohan Tarkalankar College and Nabadwip Vidyasagar College agree that detailed terms and conditions that guide each activity identified above will be determined separately and agreed upon by the two colleges. These terms will include a technical description of the proposed activity, financial arrangements and person(s) responsible for its implementation.

## **ARTICLE 2: COORDINATION**

Each college shall appoint one member of its teaching faculty to coordinate the programme on behalf of the Principal of each college further, a Coordination Committee consisting of two Principals and the two Coordinators will periodically (once or twice a year) review and identify ways to strengthen cooperation between two colleges.

## **ARTICLE 3: CONFIDENTIAL INFORMATION**

The two colleges will retain and respect individual confidentiality, including those pertaining to the collaborative activities of both colleges.

## **ARTICLE 4: INTELLECTUAL PROPERTY RIGHTS**

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software and any other industrial or intellectual property



rights) developed jointly during the course of this MoU shall be vested in both the colleges in this MoU. Both the colleges shall have right to determine the commercial implications, disposition and exploitation of such intellectual property and shall make joint applications for the registration of the same. Any publication regarding such intellectual property shall be possible with prior written consent of both colleges.

### ARTICLE 5: VALIDITY

Initially, the MoU shall remain in force for a period of Three years commencing from the effective date. Institutions may extend the term by written agreement signed by both after review.

### ARTICLE 6: TERMINATION

Either institution may terminate the Mou by giving written notice of One month in advance to the other institution.

### ARTICLE 7: LEGAL EFFECT

Nothing in this MoU shall be construed as creating any legal relationship between the two colleges. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

### ARTICLE 8: DISPUTE RESOLUTION

In case of a dispute relating to any aspect of academic cooperation, Principals of both colleges will jointly resolve the dispute in a spirit of independence, mutual respect and shared responsibility.

Asannagar Madan Mohan Tarkalankar College and Nabadwip Vidyasagar College welcome the establishment of this Memorandum for cooperation and jointly agree to the provisions set out as above.

The general objective of this Memorandum of Understanding (MoU) is to stimulate and facilitate the development of collaborative and mutually beneficial programmes which serve to enhance the intellectual life and cultural development on both campuses, and to contribute to increased inter-college cooperation. Thus, Sewnarayan Rameswar Fatepuria College and Nabadwip Vidyasagar College have agreed that in support of their mutual interests in the field of education and research:

1. The two Colleges will:
  - a) Cooperate in the exchange of information relating to their activities in teaching and research in fields of mutual interests;
  - b) Promote appropriate joint research projects and joint courses of study, with particular emphasis on internationally funded projects;
  - c) Endeavour to encourage students and staffs to spend periods of time in the host College.
  - d) Conduct short courses, cultural projects and study tours as mutually agreed in writing between the parties prior to commencement of these activities;
2. Accreditation for academic work carried out by any student during the period of study at the host College will be at the discretion of the student's home College.
3. Admission to a specific department or course is subject only to a student being satisfactorily qualified for the chosen area of study and the availability of resources in the period for which admission is sought.
4. The aim of the Memorandum of Understanding shall be to achieve a broad balance in the respective contributions and benefits of the collaboration, and this shall be subject to periodic review by both Colleges.
5. All other financial matters, including travel costs, are subject to individual negotiation, and will normally be the responsibility of the persons involved and their home College.
6. The host College agrees to assist in supplying work space, Library and technical facilities as appropriate.

This agreement will take effect from 1<sup>st</sup> January 2022 to 30<sup>th</sup> June 2027 unless sooner terminated, revoked or modified by mutual written agreement between the Parties and may be extended by mutual written agreement.

Either party may terminate the Agreement at any time by the provision of three months' written notice to the other party.
