
1. Alternate sources of energy and energy conservation measures

The college uses solar energy Power Unit as an alternative source to satisfy the partial requirement of the day to day needs of the college. The college gets 20 KVA= 1600 watt energy from the solar power in a week. This unit normally fulfil our requirement of 1040 KVA i.e. 54,080 watt in a single year (Formula: 20KVA * 52 weeks= 1040KVA in a year & 1600watt * 52 weeks= 54,080 watt in a year). The solar power units are maintained and monitored regularly. The college also makes use of LED lights and bulbs to minimise the power consumption of the electricity.


















